# OFFICIAL CONTEST RULES AND TERMS & CONDITIONS FOR THE "LUNAR NEW YEAR CONTEST" FROM THE ATLANTIC LOTTERY CORPORATION ("ALC")

The "Lunar New Year Contest" provides alc.ca players with a chance to win one (1) of six (6) cash prizes totaling \$25,000.

Note: PEI residents are not eligible for this contest.

From February 9th to February 25th, 2024, every \$10 wagered on select Casino\* games, on alc.ca, on each day of the contest (see eligible games below) will earn the player one (1) entry into the contest. To earn entries, players must have valid, active and funded alc.ca account, be 19 years or older and a resident of New Brunswick, Newfoundland and Labrador or Nova Scotia.

\*Casino games are not available in PEI.

# **CONTEST PERIOD**

The "Lunar New Year Contest" will take place from February 9th, 2024, at 00:00:00 AT to February 25<sup>th</sup>, 2024 at 23:59:59 AT (the "Contest Period").

# **HOW TO PARTICIPATE**

During the Contest Period, every \$10 wagered on select games, on alc.ca, on each day of the contest (see eligible games) will earn the player one (1) automatic entry into the draw for a chance to win. Players can earn a maximum of one hundred (100) entries per day during the contest period.

Potential winners will have seven (7) days to provide their information once an Atlantic Lottery representative has contacted them via email. No purchase is necessary to enter this promotion. See below for more details.

# **DRAWS AND PRIZES**

A player has a chance to win one (1) of six (6) prizes totaling \$25,000 in cash.

One (1) prize of \$7,500.

Two (2) prizes of \$5,000.

Three (3) prizes of \$2,500.

The odds of winning a prize will depend upon the total number of eligible entries received during the Contest Period. If the potential winner has not contacted ALC within seven (7) days of being contacted, ALC shall have the right to disqualify the potential winner and draw an alternate winner for the same prize. #### **RANDOM DRAW AND ODDS**

On Thursday, February 29<sup>th</sup>, 2024 (or as soon as possible thereafter) a random draw will be conducted for each prize from all eligible entries received during the contest period. #### **ELIGIBILITY**

#### **DELIVERY OF PRIZES**

ALC will attempt to contact the potential winner within one (1) business day after the draw (or as soon as possible thereafter). If ALC is not able to contact the potential winner after seven (7) days after the initial attempt, ALC shall have the right to disqualify the potential winner, and the entry drawn immediately

after the disqualified entry for the prize will be eligible to win the prize that otherwise would have been awarded for the previously selected entry.

Government issued photo identification must be provided for proof of identification and age. If the winner is under the age of 19 they will be disqualified, and the next potential winner will be contacted. Winners will be notified by phone or email.

Winner must provide the completed release form issued by ALC, proof of identification and Payment Option form in person or via scanner or fax machine within seven (7) days of being contacted; failure to do this will result in the winner waiving his/her right to the prize. The release form and prize form must be completed before any prize is issued by ALC.
