

OFFICIAL CONTEST RULES AND TERMS & CONDITIONS FOR THE “WINTER WIN-DERLAND CONTEST” FROM THE ATLANTIC LOTTERY CORPORATION

The “Winter Win-derland Contest” provides alc.ca players with a chance to win one (1) of six (6) cash prizes totaling \$25,000.

From January 12th to January 25th, 2024, every \$5 wagered on select games, on alc.ca and/or the Atlantic Lottery app, on each day of the contest (see eligible games below) will earn the player one (1) entry into the contest. To earn entries, players must have valid, active and funded alc.ca account, be 19 years or older and a resident of Atlantic Canada.

Note: Casino games are not offered in PEI and residents of PEI are only eligible to enter the Contest via those Eligible Games that are not on Casino.

CONTEST PERIOD

The “Winter Win-derland Contest” will take place from January 12th, 2024, at 00:00:00 AT to January 25th, 2024 at 23:59:59 AT (Contest Period).

HOW TO PARTICIPATE

During the Contest Period, every \$5 wagered on select games, on alc.ca and/or the Atlantic Lottery app, on each day of the contest (see eligible games) will earn the player one (1) automatic entry into the draw for a chance to win. Players can earn a maximum of one hundred (100) entries per day during the contest period.

Potential winners will have seven (7) days to provide their information once an Atlantic Lottery representative has contacted them via email. No purchase is necessary to enter this promotion. See below for more details.

DRAWS AND PRIZES

A player has a chance to win one (1) of six (6) prizes totaling \$25,000 in cash.

One (1) prize of \$7,500.

Two (2) prizes of \$5,000.

Three (3) prizes of \$2,500.

The odds of winning a prize will depend upon the total number of eligible entries received during the Contest Period. If the potential winner has not contacted ALC within seven (7) days of being contacted, ALC shall have the right to disqualify the potential winner and draw an alternate winner for the same prize. ALC shall be fully and completely released and discharged from any liability or responsibility in this regard. Government issued photo identification must be provided for proof of identification and age. If the winner is under the age of 19 they will be disqualified and an alternate winner for the same prize will be drawn.

Prize package is non-transferable.

An entrant can win only one (1) prize.

RANDOM DRAW AND ODDS

On January 31, 2024 (or as soon as possible thereafter) a random draw will be conducted for each prize from all eligible entries received during the contest period. The odds of winning the prize will depend upon the total number of eligible entries received during the Contest Period. All draws adhere to the draw procedures established for the draw by Atlantic Lottery.

ELIGIBILITY

This promotion is sponsored by Atlantic Lottery Corporation (ALC) and is open to residents of New Brunswick, Newfoundland and Labrador, Nova Scotia and **Prince Edward Island; who are nineteen (19) years of age or older; and reside in Atlantic Canada, with the exception of employees of Atlantic Lottery or any immediate family of the aforementioned. 'Immediate Family' means the spouse, sibling, parent and/or child of an employee referred to above who resides with that employee.

Please note: Any individual who has falsified their registration information will be ineligible to receive their prize upon winning.

No purchase is necessary to enter. Players can obtain an online entry which will be added by an AL contest official. Players can obtain this by sending a 200-word description of why they would want to win a prize and the alc.ca username of the entrant. All requests for an online entry must be received by Atlantic Lottery by 12:00pm the day of the draw as documented in these rules.

DELIVERY OF PRIZES

Atlantic Lottery Corporation (ALC) will attempt to contact the potential winner within one (1) business day after the draw (or as soon as possible thereafter). If ALC is not able to contact the potential winner after seven (7) days after the initial attempt, ALC shall have the right to disqualify the potential winner, and the entry drawn immediately after the disqualified entry for the prize will be eligible to win the prize that otherwise would have been awarded for the previously selected entry.

Government issued photo identification must be provided for proof of identification and age. If the winner is under the age of 19 they will be disqualified, and the next potential winner will be contacted. Winners will be notified by phone or email.

Winner must provide the completed release form issued by Atlantic Lottery, proof of identification and Payment Option form in person or via scanner or fax machine within seven (7) days of being contacted; failure to do this will result in the winner waiving his/her right to the prize. The release form and prize form must be completed before any prize is issued by Atlantic Lottery.
