

## **OFFICIAL TERMS & CONDITIONS FOR THE “INSTANT WINS AND CASINO DEPOSIT BONUS JUNE 2024” PROMOTION FROM THE ATLANTIC LOTTERY CORPORATION (ALC)**

The "Instant Wins and Casino Deposit Bonus June 2024" promotion is available to residents of Nova Scotia, New Brunswick, and Newfoundland and Labrador from 00:00:00 Atlantic Standard Time (AST) on June 28, 2024, to 23:59:59 AST on June 30, 2024. **This promotion is not available to residents of Prince Edward Island.** Participants must have a valid, active and funded alc.ca account.

To earn the \$25 Deposit Bonus, a player must deposit a total amount of at least \$50 into their alc.ca account and spend a total amount of at least \$25 on Instant Wins games and/or Casino games available on alc.ca during the Promotion Period. The spend requirement can be met by spending \$25 on one (1) game category (Instant Wins or Casino) or through a combination of spends on both categories that totals \$25. Participants can earn one (1) \$25 Deposit Bonus during the Promotion Period.

### **PROMOTION PERIOD**

The promotion will take place between 00:00:00 on June 28, 2024 and 23:59:59 on June 30, 2024 (“Promotion Period”).

### **HOW TO PARTICIPATE**

To participate in this promotion:

1. Participants must deposit a total amount of at least \$50 into their alc.ca account and spend a total amount of at least \$25 on Instant Wins games and/or \$25 on Casino games available on alc.ca during the Promotion Period. The entire \$25 must be spent on one (1) game category (Instant Wins or Casino) to be eligible for the Deposit Bonus.
2. The \$50 deposit and \$25 spend requirements can be met through multiple deposits and spends. The spend requirement can be met by spending \$25 on one (1) game category (Instant Wins or Casino) or through a combination of spends on both categories that totals \$25. Promo cash will not be accepted as a funding option.
3. The \$50 deposit criteria can only be met by a player manually adding funds to their alc.ca account. Online lottery subscriptions and lottery winnings automatically deposited into accounts will not be considered deposits for this promotion.
4. Once all criteria are met, the player will receive their \$25 Deposit Bonus directly into their alc.ca account within 48 hours.
5. To participate in the promotion: participants must be 19+; must be a resident of New Brunswick, Nova Scotia or Newfoundland and Labrador; and must have an active and funded alc.ca online account.

6. The offer will run from 00:00:00 Atlantic Standard Time (AST) on June 28, 2024 and closes at 23:59:59 AST on June 30, 2024.

### **PROMOTION REWARDS**

1. Eligible participants can earn one (1) \$25 Deposit Bonus during the Promotion Period.
2. Once all criteria are met the player will have their \$25 Deposit Bonus deposited directly into their alc.ca account within 48 hours.
3. The \$25 Deposit Bonus can be used for alc.ca purchases only. Not exchangeable for cash or cash equivalents.
4. This Promotion is non-transferrable.
5. Limit of one (1) \$25 Deposit Bonus per alc.ca member/account.
6. Offer is available to residents of New Brunswick, Nova Scotia and Newfoundland and Labrador only.

### **PROMOTION ELIGIBILITY**

This offer is sponsored by Atlantic Lottery (ALC) and is open to residents of New Brunswick, Newfoundland & Labrador and Nova Scotia, who are nineteen (19) years of age or older, have an active and funded alc.ca account, and reside in Atlantic Canada at the time of entry. This promotion is not available to residents of Prince Edward Island.

Please note: Any individual who has falsified their registration information will be ineligible to receive their \$25 Deposit Bonus.

### **DELIVERY OF PRIZES**

The \$25 Deposit Bonus will be deposited directly into alc.ca account within 48 hours.
