RULES AND REGULATIONS FOR THE "HEALTHY PLAY CONTEST" FROM ATLANTIC LOTTERY CORPORATION

HOW TO ENTER

In each monthly contest period:

- Players can earn a maximum of thirty (30) entries into the monthly draw.
 - o Players can earn five (5) entries into the monthly draw by having a wager limit set.
 - Players can earn five (5) entries into the monthly draw by having a session limit set.
 - Players who keep both limits set until 11:59:59 p.m. AT on the final day of the monthly contest period will receive twenty (20) bonus entries into the draw.
- Players can adjust their limit as needed.
- The monthly draw will reset on the first day of each month from November 1, 2024 February 1, 2025.

CONTEST ELIGIBILITY

- 1. The contest is sponsored by Atlantic Lottery Corporation and is open to residents of New Brunswick, Newfoundland and Labrador, Nova Scotia, and Prince Edward Island, who are nineteen (19) years of age or older and reside in Atlantic Canada at the time of entry and draw with the following exceptions: Current employees of Atlantic Lottery Corporation (including Red Shores Racetrack & Casino), or of any promotional agency involved with this contest, and any Immediate Family members of any of these employees, which employees and their Immediate Family members shall be ineligible to participate in and/or claim any reimbursable prize for this contest.

ODDS OF WINNING

A random draw will be conducted for the prize from all eligible entries received during the monthly contest period.

The odds of winning the prize will depend upon the total number of eligible entries received during the monthly contest period. All draws adhere to the draw procedures established for the draw by ALC.

Prize Claim and eGift Card delivery: October and November

Upon selection as an eligible winner, participants will receive an email notification containing a link to access and complete a prize claim form from promotionsgroup@mail.alc.ca. This notification will be sent to the email address associated with the participant's alc.ca account. Participants are responsible for ensuring the accuracy of their account information on alc.ca.

Eligible winners will also receive a notification on their Healthy Play contest page prompting them to complete their prize claim form. Participants must be signed into the contest page to view this notification.

Eligible winners are given five (5) days from the date of notification to complete and correctly answer, unaided, a mathematical skill-testing question and submit the prize claim form within the time frame indicated. Prize claim delivery: December, January and February

OFFER PERIOD

The Healthy Play February Bonus Offer is valid and will remain available between February 14, 2025 to February 19, 2025 at 23:59:59 Atlantic Time only ("Offer Period").

HOW TO PARTICIPATE

During the Offer Period, eligible players can earn a \$10 coffee eGift card by setting a wager limit or a session time limit on alc.ca. The first 1,000 eligible players who set a wager limit or a session time limit during the Offer Period will receive a \$10 coffee eGift card. Players who are one of the first 1,000 eligible players to set a limit during the Offer Period will be notified by e-mail no later than Monday, February 24, 2025.
